2010-2011 County Budget Projections: President Brennan gave the group an update on the County's projected budget for 2010-2011. The County currently projects a deficit of \$54 million.

Labor Management and Meet & Confer reviews: The Chief's position on POs carrying knives has not changed, though the current written policy has not yet been changed. In the most recent Meet & Confer, discussion took place over the proposed Professional Appearance Policy. Discussions will be continued in February.

February General Membership Meeting: The meeting has been set for February 24th at 6:00PM in the Adult Probation Training Room. Guests are tentatively scheduled to attend.

Bylaws Review: Proposed changes were reviewed by the Board, and approved for presentation to the membership.

Christmas Party 2010: La Tosha Walden will be heading up the Christmas Party Committee once again. Duane Blevins will follow up on a possible alternate location for the party.

Donations & Community Efforts:

The 2010 "Rotary Read-In" is scheduled for March 2nd. La Tosha Walden volunteered to lead the effort on sign-ups. Paul Brennan said he would get clarification from the Chief on whether POs could get approved to work on this project on County time.

Motion made by Meredith Hammond to sponsor a local Co-Ed softball team, made up of POs, in the amount of \$300.00 made out to the City of Stockton. The check will be dispersed upon clarification with Javier Guzman, to see if the group would prefer a lump sum of the total amount or have it spread out over the year.
